# UNIVERSITY OF SCIENCE AND ARTS OF OKLAHOMA BOARD OF REGENTS MINUTES April 8, 2014

The Board of Regents for the University of Science and Arts of Oklahoma met Tuesday, April 8, 2014, in the President's Conference Room on the USAO campus. Before the meeting was called to order, President John Feaver stated that advance public notice of this meeting was properly filed and displayed in compliance with the Open Meeting Law. Chair Kitz led the group in the Pledge of Allegiance and then called the meeting to order at 12:40 and asked for roll call. **2. Financial Statements –** Vice President for Business and Finance Mike Coponiti covered the monthly and quarterly financials with the group.

#### 3. Request for Approval of 2014-2015 Board Plans

Chair Kitz called on Regent McLaughlin to report on the request to approve the 2014-2015 Board Plans. Regent McLaughlin asked Vice President Coponiti to explain and describe each cost. Regent McLaughlin recommends the Board approve the 2014-2015 Board Plans.

Board plans and rates are devised with considerable student input to maximize flexibility and optimize value. All meal plans are structured as "block" plans with a trimester parameter rather than a weekly parameter. This permits students flexibility in determining when to consume meals. Additionally, the "block" system permits "transferability," which allows students to spend some of the meals on their plans for guest diners, such as parents or friends.

Following are the various plans and rates proposed for the 2014-2015 school year. The rates proposed reflect an increase of approximately three (3) percent over this year's rates.

Declining Cash Balance (DCBs) may be purchased from and spent at any food service venue (cafeteria, Dusty's, convenience store). In addition to those attached to the various meal plans, DCBs can be purchased in increments of \$25, with the following discount structure applying:

1-99 = dollar to dollar 100-249 = 5% discount 250-399 = 10% discount 400+ = 15% discount

Meal punches remain transferable in the Dusty's and the convenience store during prescribed times.

Plan designs vary from institution to institution. The figures used represent the plan at each school that most closely matches USAO's 225 block meal plan. Like USAO, almost all institutions offer a variety of food service plans with a wide range of options that combine cash equivalency and meal punches. Declining cash balances were removed dollar for dollar for comparison.

Chair Kitz moved to accept Regent McLaughlin's recommendation to approve the Board Rates. The Board voted unanimously (4-0) to approve. (To be ratified in June meeting)

#### 4. Request for Approval of 2014-15 Housing Rates

Chair Kitz called on Regent McLaughlin to report on the request to approve the 2014-2015 Housing Rates. Regent McLaughlin asked Vice President Coponiti to explain and describe each cost. Regent McLaughlin recommends the Board approve the 2014-2015 Housing Rates.

Each year campus housing rates are reviewed and adjusted to maintain a rate structure driven by the following three priorities: 1) to generate sufficient revenue to meet the debt service obligations of Lawson Court and to adequately maintain all campus residential facilities and programs; 2) to preserve a position of affordability and equity relative to comparable facilities at other colleges and universities, and 3) to maintain reasonable and equitable price distinctions between different facilities.

In some years these rates have been raised slightly more than 3 percent in order to ensure an adequate margin for debt service on Lawson Court. However, in an effort to control cost to our students, housing rates were not adjusted last year. Projecting occupancy rates that are similar to those experienced in recent years (81% in Fall 2013), a 3 percent increase is proposed as adequate. An analysis of other institutions' housing costs indicates that USAO remains in a competitive position as a good value. In all cases, the figures proposed have been rounded to an even dollar figure ending in 5 or 0.

#### 5. Request for Approval of the Curriculum Changes

Chair Kitz called on Regent McLaughlin to report on the following request. Regent McLaughlin asked Vice President Marble to report on the proposal.

The following requests for additions, deletions, and modifications in programs and courses have originated with the respective departments, and have won approval from the appropriate faculty committees and officers, including the President.

All courses are identified by a four-digit number. The first digit (1, 2, 3, or 4) represents respective levels of freshman, sophomore, junior, and senior. The last digit represents the number of credit hours awarded for completion of the course. The middle two digits are unique to identify the specific course.

### Division: Education and Speech Language Pathology Department: Education

Curriculum changes requested in the Education and Speech Language Pathology are minor changes in descriptions of courses and course titles to conform to current practice and current terminology in the field. For example, some changes highlight the clinical nature of the course. The opportunity for undergraduate experience in a clinical situation is virtually unique to USAO. Others eliminate the requirement of passing an English Proficiency Exam which has not been given at USAO for a number of years. And others recognize USAO's initiative in making co-teaching integral to the student teaching experience.

Requested changes are listed below:

### 1. Change the course description of EDUC 4410 Professional Trimester/Student Teaching in the Secondary School

Directed observation and teaching under supervision and guidance in secondary school. Prerequisites: admission to Teacher Education, successful completion of English Proficiency requirement, *and* approval to student teaching. 10 hours.

To:

Level 4 Clinical Experience. Teaching experience with qualified mentor teachers in secondary schools. Prerequisites: Admission to Teacher Education and Approval to Student Teach. Co-requisite: EDUC 4542 Applied Professional Studies. 10 hours.

### 2. Change the course description of EDUC 4405 Professional Trimester/Student Teaching in the Secondary School

From:

Directed observation and teaching under supervision and guidance in secondary school. Prerequisites: admission to Teacher Education, successful completion of English Proficiency requirement, *and* approval to student teaching. 5 hours.

To:

Level 4 Clinical Experience. Teaching experience with qualified mentor teacher in a secondary school. Prerequisites: Admission to Teacher Education and Approval to Student Teach. Co-requisite: EDUC 4542 Applied Professional Studies. 5 hours.

### 3. Change the course description of EDUC 4310 Professional Trimester/Student Teaching in the Elementary School

Directed observation and teaching under supervision and guidance in elementary school. Prerequisites: admission to Teacher Education, successful completion of English Proficiency requirement, *and* approval to student teaching. 10 hours.

Introductory survey course dealing with educational media designed to develop understanding and familiarity with media hardware and software used in public schools. Special emphasis on media production, operation, selection, use, and evaluation techniques of wide range of educational media, particularly microcomputers. Prerequisite: Admission to Teacher Education. 3 hours.

#### To: EDUC 3343 Educational Technology

Emerging technologies have capabilities to empower learning in and out of classrooms. The course focuses on interactive educational tools, applications, media, and infrastructures with emphasis on using the technologies associated with course content. 3 hours.

II.

Division: Science and Physical Education Department: Physical Education

The requested changes are for a minor change in a course description, and for the addition of a course that has been taught as a special topics course for the last five years.

Requested changes are listed below:

### 1. Change the course description of PHED 3352 Theory of Coaching Interscholastic Sports

From:

Emphasis on coaching major team sports. Instruction includes psychology of coaching; certification of coaches; finance and budgeting; purchase, care, and repair of equipment; methods of scheduling; rules of the sport; and

fundamentals of offense and defense. (May be repeated for a total of 8 hours, 2 hours each in baseball, basketball, football and track and field.) 2 hours.

To:

Emphasis on coaching major team sports. Instruction includes psychology of coaching; certification of coaches; finance and budgeting; purchase, care, and repair of equipment; methods of scheduling; rules of the sport; and fundamentals of offense and defense. (May be repeated for a total of 8 hours, 2 hours each in baseball, basketball, soccer and cross country.) 2 hours.

(Note: The coaching subjects correspond to the intercollegiate sports in which USAO currently participates. USAO does not compete in football or track and field, and consequently expertise in the department in those sports is limited.)

#### 2. Add a new course, PHED 3XX2 Sport in Film and Literature

#### **Course Description:**

The course analyzes sport in popular culture through the mediums of film and literature. The course analyzes a number of critical topics in sport as depicted through various films and their corresponding literary piece. Issues such as gender, race, and class will be investigated.

This course has been taught as a special topics course on a regular basis for several years. It is time to make it an official course. In Spring 2014, films assigned include *Olympiad, Chariots of Fire, Great White Hope, Raging Bull, Personal Best, Miracle, Breaking Away, and North Dallas Forty.* 

III.

Division: Science and Physical Education Department: Natural Science

The changes outlined below are less complex than it would appear. For some fifteen years, all students majoring in one of the sciences have been required to enroll in either NSCI 2700 or NSCI 2701 during all Fall and Spring trimesters at USAO. Students could take the course either on a pass/fail basis for zero credit, or for one hour of credit that received a grade.

#### I. Delete the following course(s):

#### **NSCI 2700/1 Colloquium in the Sciences**

Course provides a forum for student and faculty presentations, viewing of videotapes, organizing field trips, discussion of science and technology-related subjects and developing a broad understanding of the ideas and methods of science. The Colloquium will serve as the organizational and administrative vehicle for the completion of the science portfolio. All majors in biology, chemistry, medical technology, natural science and physics are required to participate each fall and spring trimester. Students in science-related fields are encouraged to participate. Attendance is open to all students.

Delivery of the course has presented problems. Requirement of enrollment every trimester has meant that subject matter cannot be repeated over a four-year period. Such enrollment, furthermore, puts freshmen, sophomores, juniors, and seniors into the same material. The requirement, although valuable, is also a drain on both faculty and student time.

Accordingly, we propose the following change to preserve the value of the experience and to resolve various issues connected with delivering the course. We would replace the 8-trimester experience with 3 trimesters, one each at the freshman, sophomore, and junior levels, each devoted to separate practical concerns. All three courses are required of all majors in biology, chemistry, physics, and natural science. The second two courses are required of all mathematics majors.

#### 2. Add the following courses:

#### **NSCI 1XX0/1 Success in STEM (taught every Fall)**

This course introduces students majoring in STEM (Science, Technology, Engineering, and Mathematics) areas to strategies for success in these fields of study. The course familiarizes students with the policies, resources including laboratories, and skills affiliated with success in STEM fields. 0 or 1 credit hour.

#### NSCI 2XX0/1 STEM Communication (taught every Spring)

This course is for students majoring in STEM (Science, Technology, Engineering, and Mathematics) fields of study. The course emphasizes STEM communication including scientific reasoning via primary literature, discussion, poster, and oral presentations. 0 or 1 credit hour.

#### **NSCI 3XX0/1 Next Step Preparation (taught every Spring)**

This course is for students majoring in STEM (Science, Technology, Engineering, and Mathematics) fields of study. The course emphasizes the preparation necessary for a career in STEM including jobs, graduate school, professional school, and service. 0 or 1 credit hour.

#### 2. Add and drop the following courses:

#### Add: BIOL 4880 - Special Topics

Special topics in biology, 1-4 hours (may be repeated for a total of 6 hours)

This special topics course is listed under chemistry, physics, natural science, and mathematics, but apparently has been inadvertently omitted from biology. This will provide consistency throughout the STEM majors.

#### Delete: **BIOL 4800 - Biological Projects**

Research and seminar projects; may be taken unlimited number of times. 1-3 hours (credit to be arranged by instructor). Prerequisites: 8 hours of biology *and* permission of instructor.

This course does not appear under any of the other STEM majors at USAO. No one on the faculty can remember its ever having been taught. Furthermore, the type of project envisioned by this course can be completed by satisfying requirements for USAO's Research Endorsement, rendering this course superfluous.

Chair Kitz moved to accept Regent McLaughlin's recommendation to approve the curriculum changes. The Board voted unanimously (4-0) to approve. (To be ratified in June meeting)

Vice President Trevino gave a report to the USAO Regents on recruiting and admissions.
