# UNIVERSITY OF SCIENCE AND ARTS OF OKLAHOMA BOARD OF REGENTS <br> MINUTES <br> December 13, 2017 

The Board of Regents for the University of Science and Arts of Oklahoma met Wednesday, December 13, 2017, in the President's Conference Room on the USAO campus. Before the meeting was called to order, President John Feaver stated that advance public notice of this meeting was properly filed and displayed in compliance with the Open Meeting Law. Vice Chair Ming led the group in the Pledge of Allegiance and then called the meeting to order at 1:30 and asked for roll call. ## 3. Request for Approval of Academic Program Reviews -

The Oklahoma State Regents for Higher Education (OSRHE) issued their initial "Policy Statement on Program Review" in 1985. It directs all system institutions to develop campus level criteria and processes for the review of all educational programs. Review results are to be used to make campus determinations about the quality, efficiency, and effectiveness of instructional programs and ultimately to provide information to assist the State Regents in making decisions concerning the purposes and missions of state system institutions.

The State Regents require that academic programs be reviewed on a continuing five-year cycle. This year USAO is reviewing six programs as a part of that cycle: Chemistry, Economics, Mathematics, Physics, Sociology and Theatre Arts. Each program is discussed below.

## Chemistry

The chemistry faculty consists of two full-time faculty members who hold the Ph.D. Two additional full-time faculty members support the chemistry program, one from Biology and the other representing Natural Science. Both additional faculty members hold Ph.D.'s in their respective field. Besides serving the chemistry major, the faculty generate many additional credit hours through staffing the IDS program and offering required service courses to other majors. The chemistry faculty recently received a grant for the Summer Mentoring and Research Training (SMaRT) Program through the Oklahoma IDeA Network of Biomedical Research Excellence (OK-INBRE) and research funding from the USAO Foundation and provide opportunities for students to participate in undergraduate research.
Department members note that facilities are generally adequate, but that equipment will need to be replaced and expanded. Members also note that although the quality of the post-graduate opportunities for USAO chemistry graduates is impressive, the numbers of chemistry majors need to be expanded. Faculty members further note that chemistry is integral to the IDS program, and that they participate actively in the IDS program.

In Spring 2016, OSRHED identified chemistry as "low-producing." The five-year average of declared majors is 12. The five-year average for graduates is 1.2. Two of the graduates are working in Oklahoma in a chemistry related field while three others have employment in fields relevant to chemistry out of state. USAO has requested an exception based upon the integral nature of chemistry as one of the traditional arts and sciences.

Recommendations for the program include continued revision and enhancement of curricular offerings and a gradual growth in the number of majors and minors through increased recruiting efforts and a focus on retention.

## Economics

The economics faculty consists of two full-time faculty members who hold the Ph.D. in economics. One additional full-time faculty member from Business and three adjunct faculty support the economics program. Besides serving the economics major, the faculty generate many additional credit hours through staffing the IDS program and offering required service courses to the business major, one of the biggest programs on campus. Much of the load of one of the faculty members is in the IDS core and she serves as the IDS coordinator.
The five-year average of declared majors in economics is 13 and the five-year average for graduates is 3.2. To note, these numbers are an increase to the averages reported for the previous 5 -year program review where the number of majors averaged five and the number of graduates averaged at two over academic years 2007-2011. The number of
average graduates placed economics in the "low-producing" category and USAO requested an exception based upon the integral nature of economics as one of the traditional arts and sciences. USAO's requirement of an economics component in its general education program was a major factor in the award of an "A" rating from the American Council of Trustees and Alumni.

Recommendations from the program review include recruitment of more majors in the form of additional double-majors from the math/science students. An additional recommendation is to encourage student engagement in community activities and policy forums.

## Mathematics

The mathematics faculty consists of three full-time faculty members and two adjunct faculty. Two of the full-time faculty hold the Ph.D. and one is in a visiting position and has a master's of science in mathematics. In addition to servicing majors, the mathematics faculty provides service courses for accounting, biology, business, chemistry, elementary education, medical technology, physics, pre-health science, psychology, sociology, and natural science. Furthermore, mathematics is integral to the liberal arts mission of USAO. Of note, is the offering of Preparation for Industrial Careers in Mathematical Sciences (PIC Math) that has been offered every spring since 2015. In addition, Mathematics faculty have taught interdisciplinary courses that satisfy USAO's general education requirements including Origami and the team-taught World Thought and Culture courses.
The number of majors during the last five years has averaged approximately 19 with an average of 4.6 graduates. Of the sixteen graduates we had data on, seven went on to graduate studies, three are teaching, with the rest employed in industry. With the number of average graduates just under the required number of five, the mathematics program was placed in the "low-producing" category and USAO requested an exception based upon the integral nature of economics as one of the traditional arts and sciences.
Recommendations for the program are to broaden statistics offerings and to gradually grow the number of majors through recruitment and retention efforts. Another recommendation includes the initiation of computer-based mathematics courses.

## Physics

The Primary physics professor is also the Division chair. He holds a Ph.D. in Physics and the program is supported by three additional full-time faculty, two mathematics faculty and a chemistry faculty member all who hold a Ph.D. in their discipline.
In Spring 2016, OSRHED identified physics as "low-producing." USAO requested an exception based upon the integral nature of physics as one of the traditional arts and sciences and the minimal resources needed to keep the program. The five-year average of declared majors in physics is 8.6 and the five-year average of graduates is 0.8 . This is an increase from the last 5 -year program review, which reported an average of 6 majors and zero graduates. Recent graduates are pursuing graduate education at the University of Houston, Rice University and MD Anderson.

Physics is a traditional science that supports the general education program of USAO and is essential to USAO's assigned mission. The physics professor teaches in the required interdisciplinary sequence that is required of all students at USAO. Certain physics courses are required to support the very healthy major program of biology. Physics further supports USAO's teacher preparation program. Cutting the program would not result in meaningful savings; USAO would still need to have a physics professor to pursue its mission effectively.

Recommendations include curriculum revision based on assessment data and graduate feedback along with a gradual and limited growth in the number of majors.

## Sociology

The sociology department presently consists of one associate professor who holds the Ph.D. and is exceptional in developing student interest in the subject, which is evident in the increase (95\%) in the number of majors since his hire. The department also relies on adjunct instructors.

The five-year average of declared majors increased from 22 during the past fiveyear program review to 43 and the average number of graduates increased from four to 8.2, removing it from the "low-producing" category. During the review period, there were 43 graduates with a bachelor's in sociology. We have data for 30 ( 69.8 percent) of these graduates. Of those 30 students, 13 went into the labor market after graduating and are currently employed full time, four went on to graduate school and are now employed full time, one is working full time while enrolled in graduate school, seven are currently enrolled in graduate school full time, one is concurrently enrolled in graduate school and law school, two are currently applying to graduate school, one is currently looking for work, and one returned to undergraduate studies to pursue a double- bachelor's degree.

Recommendations include a reconfiguration of the criminal justice minor, the development of an emphasis in the major on social work, and to increase internship opportunities for students. Additional recommendations include the development of a steady rotation of courses, increasing visibility of the program, and developing a comprehensive assessment plan for the program.

## Theatre Arts

The "generalist" faculty member in this program is uniquely capable of being the director, designer, production manager, and academic advisor to all students. The curriculum of the program is of the highest quality and demonstrates ongoing commitment to growth and the effort to keep both production practice and scholarship contemporary and competitive. This program has led service pilot projects, including a collaboration on a production with Oklahoma City Community College, a collaboration with the City of Chickasha for Shakespeare in the Park, and an outreach performance at Chickasha public schools. The faculty of the program has been involved in service on the boards of professional theatres in the region, maintains professional memberships, and has been recognized for excellence in teaching by the Oklahoma Speech Theatre Communication

AssociationTheatre Arts is one of the performing arts that is essential to the assigned mission and purpose of USAO.
The number of students declared as Theatre Arts majors has increased from a five-year average of 15 reported in the last program review to a five-year average of 31.2. The average number of graduate over the past five years is four per year. Graduates of the program have been accepted to graduate programs, have completed master's degrees, and are employed at schools, theatres, libraries, and non-profit organizations with a high level of satisfaction.

The department produces one major production each Fall and Spring trimester. Budgets for these productions are small. The Theatre Arts program is supported by music faculty, and IDS instructor that manages the costume shop, adjuncts, and a technical director/facilities manager. During the 2015-2016 academic year the department had a second dedicated faculty member that left for his dream job in New York City.
The theatre arts program has the potential for growth and as such it makes the following recommendations: 1) Renovations to the Davis Hall "Lab" Theatre. 2) The transition of nine special topics courses into regular offered courses listed in the catalog. 3) Increase in personnel including an additional facilities management staff person, technical theatre faculty, and part-time costume shop manager. 4) An increase in the operational budget of \$20,000.

Regent Mosley recommended approval of the Academic Program Review, and the Board voted unanimously to approve the Academic Program Reviews.
