**2. Monthly Financial Statements**– Vice President for Business and Finance Mike Coponiti covered the monthly financials with the group.

**3. Request for Acceptance of FY2014-2015 External Audit Report -** Becky Fleming CPA, INC. of Norman, concluded the annual external audit of the University for the period ending June 30, 2015. Their audit was conducted in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*. They also completed a report on <u>Compliance and Internal Control Over Financial Reporting Based on an Audit of Financial Statements</u> performed in accordance with Government Auditing Standards. Additionally, they prepared a report on <u>Compliance with Requirements</u> <u>Applicable to Each Major Program and Internal Control Compliance</u> in Accordance with OMB Circular A-133.

Regent McLaughlin asked Becky Fleming to report to the Board. A copy of the audit was distributed, and Ms. Fleming gave a review of the audit's contents to the Board. She concluded in emphasizing the audit received an unqualified opinion.

Ms. Fleming answered questions and asked if the Board would like to meet in a closed session as allowed by auditing best practices, but the Board declined.

Regent McLaughlin recommended the approval of the audit, second by Regent Bynum and the Board approved the audit unanimously (5-0).

**4. Request Action on the USAO Soccer Field** – President Feaver asked the Board to approve the name of the USAO soccer field to McLaughlin Field.

On a motion by Regent Ming, seconded by Regent Bynum, the Board voted to approve the USAO Soccer Field name to McLaughlin Field. (4-0-1)

# 5. Request for Approval of a New Degree – Public Policy Major

**Rationale:** There are currently no Oklahoma universities that offer a Public Policy major for undergraduates, so USAO's program would be the pioneer. There is a definite need for a strong Public Policy program in our state. It will foster an ethic of public service that will supply skilled and engaged college graduates, dedicated to working in the public sector and enhancing communities across the state. Public Policy programs are offered at most high ranking universities throughout the country; however, they almost entirely focus on national and global governance. Public Policy at USAO will have a decidedly local and regional emphasis. This emphasis will encourage and enable our graduates to find jobs working in the state after they graduate. This will further develop our already strong relationships with all of the policy organizations across Oklahoma, including tribal governments. Additionally, it will help us continue our reputation as producing students who stay in the state after graduation. This degree would no doubt become a popular and prestigious major for USAO, boosting enrollment for the university overall and increasing our impact on the state and the region.

**Description:** Public Policy is an interdisciplinary degree, concentrating in courses from Political Science and Economics, but offering a wide variety of relevant coursework in other disciplines, such as Sociology and American Indian Studies. Students enrolled in the program will gain a multifaceted understanding of the political and economic implications of public policy choices, as well as their historical and cultural contexts. Through their course of study, students will learn skills in quantitative analysis, research and communication, that will serve them well in many employment options or perhaps graduate school. The unique interdisciplinary, liberal arts learning environment of USAO will help students appreciate that good public policy decisions are based on an overall understanding of how peoples' needs and desires connect with the political, economic, and social systems that surround them. This degree will provide a broadly based general policy education that will enable a student to work in the policy world upon graduation or to pursue a more specialized degree if preferred.

**Structure and Oversight:** The Public Policy major will be supervised by an advisory committee of four faculty members representing four USAO majors: Political Science, Economics, American Indian Studies, and Sociology. The advisory committee will oversee curriculum development for the major. The four members of the committee will each assume advising duties and will divvy up student advisees in an equitable manner. The advisory committee will select a chair for oversight and to call meetings as needed to address issues related to the major. The major will be implemented in the Fall of 2016 if approved prior to that time.

Chair Mosley called on Vice President Maxson to report on the process of adding a new degree. On a motion by Regent Ming, seconded by Regent Bynum, the Board voted unanimously to approve the new degree program. (5-0)

#### 6. Request for Approval of the Academic Program Reviews –

The Oklahoma State Regents for Higher Education (OSRHE) issued their initial "Policy Statement on Program Review" in 1985. It directs all system institutions to develop campus level criteria and processes for the review of all educational programs. Review results are to be used to make campus determinations about the quality, efficiency, and effectiveness of instructional programs and ultimately to provide information to assist the State Regents in making decisions concerning the purposes and missions of state system institutions.

The State Regents require that academic programs be reviewed on a continuing fiveyear cycle. This year USAO is reviewing six programs as a part of that cycle: Biology, English, History, Music, Psychology, and Health, Physical Education and Recreation. Each program is discussed below.

#### Biology

The biology faculty consists of four full-time faculty members. Three hold the Ph.D. degree and one is expected to earn the Ph.D. this May. Over the past five years the program has averaged 49 majors and 8 graduates. Primary concerns are the attrition of students which has lead the department to revise its curriculum and to create a three course sequence for STEM majors (Success in STEM, Communication in STEM, and Next Step Preparation) to facilitate retention and student success. Success in STEM focuses on the transition to college and emphasizes study and time management skills. In Communication in STEM, students investigate and practice science communication, including writing, oral presentations, and outreach. Next Step Preparation helps students prepare for life after their degree by focusing on resumes, cover letters, internships, undergraduate research, and applications for the workforce or graduate school. The Biology program could use some dedicated lab space for research. Currently it is not possible to set up and leave an experiment running. An impressive number of recent graduates of the biology program are attending graduate and professional schools. Faculty members further note that biology is integral to the IDS program, and that they participate actively in the IDS program.

### English

The English faculty consists of four members, all of whom hold the Ph.D. Over the past five years the program has averaged 68 majors and 7 graduates, but is on a downward trend with only 44 current majors. The faculty recognize a need to recruit more majors and are working on making it easier for transfer students to enter the course rotation. The program provides a rare combination of practical and intellectual experiences, with instruction and practice in written communication as well as literary analysis. Because the skills inherent to successful English study are so broadly applicable, students enter

the program for different reasons and graduate to pursuits as diverse as law school, public school teaching, freelance writing, and technical editing.

Members staff the IDS writing courses which are at the core of the special IDS curriculum at USAO.

#### History

The history faculty consists of three members, all of whom hold the Ph.D. Over the past five years the program has held steady averaging 61 majors and 12 graduates. History is integral to the IDS mission at USAO, and all faculty members participate actively in the IDS program. The faculty in the department are dedicated to the success of their students as demonstrated by the extensive amount of time dedicated to their advising and to the success of their graduates with 100% of their teaching candidates finding employment as a social studies teacher while many of their other graduates go on to graduate studies. A continuing concern for the program is the desire to support foreign language requirements for a degree in history with an expanded foreign language program.

#### Music

The music faculty consists of four members, all of whom hold the doctorate. Over the past five years the program has averaged 40 majors and 6 graduates, but is on a downward trend with only 29 current majors. The faculty recognize the need to recruit more students and as a result have dedicated their earmarked foundation funds to support more scholarships along with a rigorous advertising campaign. The music faculty participate in the IDS program, and music is an integral part of the program. USAO graduates with the B.A. in Music Education are virtually assured of a job in Oklahoma. Those graduates with the B.A. in music pursue graduate study, private teaching, church music careers, and in some cases, careers outside music.

### Psychology

The psychology department presently consists of one faculty member, an assistant professor who holds the Ph.D. Over the past five years the program has averaged 92 majors and 18 graduates. A search for another full-time faculty member has been suspended due to the budget crisis but is a priority once funds are available to make a hire. Recent graduates have been accepted, are currently attending, or in some cases have graduated from graduate programs in several Oklahoma universities as well as the University of Waikato in New Zealand (behavioral analysis), and one will begin this fall at Central Washington University (cognitive neuroscience). The psychology department is integral to the IDS program with faculty regularly teaching three of the IDS core courses. The one faculty member is currently working to establish our own Institutional Review Board (IRB) essential for conducting research involving human subjects. Establishment of the IRB will help support grant submission as IRB approval is necessary for most federal grants. We are in need of another faculty member to keep up with the demand of the program. Another weakness is a lack of resources to support student research.

#### Health, Physical Education and Recreation

The HPER department consists of an associate professor and professor, both of whom hold the Ph.D. Three coaches that hold master's degrees provide support for the program. Over the past five years the program has averaged 82 majors and 14 graduates. As part of its academic program, the department provides the community with numerous classes and activities directed toward seniors, youth, and others. The department contributes to the concept of a "sound mind in a sound body." The department services the IDS curriculum with the course Concepts of Health and Fitness. Major concerns are the condition of the facilities in the old gymnasium building; there needs to be a complete renovation of the old gym. The gym is used by instructors for activity classes, fundamental sport skill classes, and laboratory exercises. The building has been used extensively in these areas and is in line for a thorough renovation as little has changed since its construction in 1924.

On a motion by Regent Bynum, seconded by Regent McLaughlin, the Board voted unanimously to approve the Academic Program Reviews. (5-0)
