# **September 14, 2022**

On a motion by Regent Ferrell, seconded by Regent Francais, the Board voted unanimously to approve the personnel actions.

**2. Financial Statements –** Vice President for Business and Finance Mick Coponiti covered the monthly financials with the group.

**3. Report on Financial Aid for FY21-22—** Director of Financial Aid Robyn Rogers reported on Financial Aid for FY21-22.

**4. Request for Approval on Suspension of Academic Programs –** Regent Wilkerson asked Vice President Miles to report on the decision to put the following programs on suspension; Public Policy, Political Science, and Multidisciplinary Studies. Vice President Miles reported that it was better for the university to suspend the programs than have the State Regents close them down. By suspending for 3 years USAO can at any time and remove the suspension. Regent's Wilkerson asked that Vice President Miles keep the Board updated.

On a motion by Regent Wilkerson, seconded by Regent Ferrell, the Board voted unanimously to approve the suspension of the academic programs.

5. Request for Approval to Enter into a Formal Agreement with Redlands
Community College to Collaborate in the Offer of Select Programs, Functions and
Services – President Feaver reported that USAO and Redlands would remain two
independent Boards. Chancellor Garrett is encouraging the collaboration along with the
chair and vice chair of the State Regents. Vice President Miles will become VPAA for both
campuses along with, Sheppard McConnell Associate Vice President for Enrollment
Management, Adeel Siddiqui Network Security System Administrator, and sharing a
Director of Printing Services. Regent McLaughlin applauded this bold move between

USAO and Redlands Community College. Chancellor Garrett and the State Regents are quite pleased with this initiative.

On a motion from Regent Francais, seconded by Regent Wilkerson, the Board voted unanimously to approve entering into a Formal Agreement with Redlands Community College to Collaborate in the Offer of Select Programs, Functions and Services.

### 6. President's Report -

- a. Foundation Vice President Audas reported that there will be a 45% increase in private giving which comes to around \$900,000 for 2022. He handed out a piece called "Donor Correspondence Toolkit", and discussed some of the projects now in process. He also praised his assistant Jennifer Dooley for alerting appropriate staff to send donors a handwritten thank you card.
- b. Small Business Development Center President Feaver reported that Science and Arts along with Redlands Community College will eventually share a downtown office space with co-sponsor Canadian Valley Technology Center.
- c. Fall Enrollment Associate Vice President McConnell reported 53% of 21-22 graduate students graduated without debt. All universities are having a hard time hiring recruiters. He thanked and praised his staff and students for doing a wonderful job giving tours of the campus. He said the Inaugural Chickasha Street and Greet was a huge success and thanked the City of Chickasha and the Chamber of Commerce. Orientation has been changed this year to keep freshman on campus for the first ten days of the term. Our collaboration with Redlands is going to greatly facilitate transfers. The annual college fair will be October 6 projecting 650 students to be on campus.
- d. Harding Fine Arts Academy Consultant Tony Hutchison reported Science and Arts is a sponsor for Harding Fine Arts Academy. It is in Oklahoma City and has 450 students. Vice President Miles and Consultant Hutchison will be meeting with them September 15<sup>th</sup> to discuss concurrent enrollment. Harding is a college prep school and their superintendent Taylor Stanton is from the University of Arizona. By state law we must make sure their application process is fair; review their monthly finances; and review and help them with their Academic Plan.
- e. Academic Reorganization VP Miles talked about the importance of academic reorganization as it related to the Redlands initiative and to our internal efforts to update the IDS general education core program. She indicated we're still waiting to finalize the MOU on a shared nursing program.
- f. Athletics Vice President Hudson reported on the large percentage (26%) of enrolled USAO students that are involved in athletic programs. He gave a brief report on athletic programs success; Soccer coach Hampton's 25 years at Science

and Arts; new bleachers in the Field House; and the imminent prospect of our athletic program assuming management oversight of the city's Sports Complex.
