ARTICLES OF INCORPORATION SECRETARY OF STATE

UNIVERSITY of SCIENCE and ARTS of OKLAHOMA ALUMNI ASSOCIATION, INC.

TO THE SECRETARY OF STATE

STATE OF OKLAHOMA

The undersigned, in order to form a not-for-profit corporation pursuant to the provisions of the Oklahoma General Corporation Act (the "Act"), certify as follows:

ARTICLE 1: NAME

The name of the Corporation is University of Science and Arts of Oklahoma Alumni Association, Inc. (Hereafter referred to as USAO Alumni Assn.)

ARTICLE 2: REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Oklahoma is; University of Science and Arts of Oklahoma, Administrative Building, Chickasha, Oklahoma 73018. The registered agent is USAO Alumni Assn.

ARTICLE 3: DURATION

The duration of the corporation is Perpetual.

ARTICLE 4: PURPOSE

The purpose of USAO Alumni Assn. shall be to perpetuate and promote the interests of the University of Science and Arts of Oklahoma; to provide leadership for the alumni to unite in their efforts to support and to strengthen the University; to disseminate information that will keep the alumni well informed about the University and the association; to encourage students to apply for admission to the University; and to take other action as may be deemed beneficial for the advancement of the University and the association.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal code.

ARTICLE 5: AUTHORIZED CAPITAL

This Corporation does not have the authority to issue capital stock.

ARTICLE 6: CONDITION OF MEMBERSHIP

The condition of membership in the corporation shall be set forth in the by-laws of the corporation.

ARTICLE 7: OFFICERS

The business and affairs of the corporation shall be managed by or under the direction of elected officers. The elected officers shall be president, president-elect, vice president, secretary, and treasurer. The treasurer must be a resident of Chickasha, Oklahoma during term of office.

ARTICLE 8: DISTRIBUTIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article 4 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not perticipate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not within the furtherance of the purposes the corporation.

ARTICLE 9: DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exampt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization, as said Court shull determine, which are organized and operated exclusively for such purposes.

ARTICLE 10: INCORPORATORS

The incorporators of the Corporation will become the officers of the Corporation upon the filing of the Certificate of Incorporation.
